READING OF MISSION

Mrs. Liparela read the Mission of the Lake-Lehman School District.

SUPERINTENDENT’S REPORT

Mrs. Liparela, Assistant Superintendent, provided a report on the following:

- Spring Musical - The Lake-Lehman Theatre Troupe will present You’re a Good man Charlie Brown next month on April 18th and 19th. Information will be shared in a global call and on the district’s Facebook page. Tonight, we welcome the Peanuts Gang to share a song with us from the production. (Cast members entertained with a musical selection.)
- Jeff Shook, Athletic Director, introduced Coach Chris Kuhar who presented Connor Runquist, with a Certificate of Athletic Achievement for being awarded District II Swimming - 500 Freestyle Champion. Coach Kuhar thanked Mr. McGovern and the Board for their support of the program.
- Mrs. Liparela announced that the Junior-Senior High School Chorus Concert is scheduled for March 17th at 7 p.m.
- Online Kindergarten Registration will open on April 1st. The online registration must be completed prior to the in-person component and screening in May. May dates are as follows for the in-person screening: May 18th - Lake-Noxen, May 19th - Lehman-Jackson and May 20th – Ross.
- The 2026-2027 school calendar is on the agenda for approval this evening. The first day of school is scheduled for August 31, 2026. This was decided based on how late Labor Day falls this year.
- There is a motion relative to PIAA playoffs on the agenda. This is in reference to non-boundary schools such as cyber, cyber/charter, private and parochial having their own athletic playoff and championship games.

BUILDINGS AND GROUNDS REPORT

Mr. Brady Butler, Buildings and Grounds Director, reported on the following:

- The Maintenance Department has been busy preparing the outdoor facilities for spring sports. The monthly turf grooming maintenance will be starting soon with a vendor inspection and testing to show the field meets all safety requirements. Mr. Butler also provided an update on the Lehman-Jackson HVAC Project and the School District Vestibule Upgrade Projects and also noted that he appreciates the patience and cooperation from staff, parents and students throughout the process.

PRINCIPAL'S REPORTS

Ross Elementary: Mr. Kostrobala, Principal, reported on the following:

- During the week of March 2nd a fun week of Read Across America activities were coordinated by Title Reading Teachers: Mrs. Ferkel and Mrs. Plisko. Special guest readers included Paralympian skier and medal winner Stephanie Jallen, skeleton participant Dan Barefoot, figure ice skater & Olympics press officer Taylor Dean, USA women's hockey goalie Ava McNaughton and WBRE news anchor Gianna Galli. The week culminated with students participating in "winter Olympics" in the gym with the aid of Ms. Miner.
- February Noble Knights were awarded for positive student behavior.

Lake-Noxen Elementary: Mr. Klopp, Principal, reported on the following:

- Lake-Noxen Elementary School, led by Dr. McDonald, recently celebrated Read Across America Week, a national week-long celebration held around March 2nd that encourages children across the country to develop a love of reading. The week is also a fun opportunity to show our school spirit while celebrating books and literacy. The events were Snuggle Up to Reading, Go Crazy For Books, Wild About Reading, Team Up and Read and Book Character Day. We had many guest readers in classrooms with the most celebrated being 13 Varsity Lake-Lehman Football Players! Throughout the week, our PTO hosted a Scholastic Book Fair, giving students the opportunity to explore new books and build their home libraries. To continue the excitement around reading, our first and second grade students are currently participating in "March Magic," where they are reading sixteen different picture books and voting to determine their favorite, ultimately selecting a champion book.
- First graders celebrated the 120th day of school by decorating shirts with 120 items and completing fun activities centered around the number 120 to meet the PA Math Standard of counting to 120. The celebration ended with a school parade where students proudly showed off their shirts
- Signs were displayed in the hallways to announce a L-N alien invasion. Mrs. Williams dressed life-sized aliens in the student's lost and found clothes and students were encouraged to collect their belongings from the display.

Lehman-Jackson Elementary: Ms. Miscavage Spagnuolo, Principal, reported on the following:

- Read Across America week was celebrated March 2nd-6th with a variety of themed outfits, reading activities and special guests. Special guest readers included Trooper Bill Evans, Jon & Renie Meyer, Mrs. Sears, the Jr/Sr High School Interact Club, Band, Softball, Girls Soccer & Lacrosse teams. The PTO hosted a book giveaway where each student was able to choose a new book to keep and also Champ's Home Run Readers, which runs through the month of March, where students record minutes reading outside of school to earn tickets to an upcoming Rail Riders game.
- Lake-Lehman elementary gifted students participated in the K'NEX STEM Design Competition held at Misericordia on March 5th. In this challenge, students were asked to design part of a factory that produces a product using sustainable practices and prepare a prototype demonstration to showcase how the machine works and supports sustainable production. The 6th grade team took 3rd place in their age group of 6-8th grade students.

- Finally, the PTO Skate Night is scheduled for next week on Thursday March 26th. The theme is Cowboys & Cowgirls. Students and siblings under the age of 16 are invited to enjoy the night.

Junior-Senior High School: Mr. Matt Nonnenberg, Principal, reported on the following:

- The Junior-Senior High School hosted an anti-bullying assembly called “Ryan’s Story” which was a huge success with positive feedback. Many students expressed how much the assembly impacted them.
- 6th grade students were invited to tour and become familiar with the junior-senior high school. They received a warm welcome from teachers and staff and also received a “Class of 2032” T-shirt. Students also watched a short video of current 7th graders explaining “What I wish I knew about 7th grade, learned how to successfully open a locker, participated in a scavenger hunt, foul shot competition and ended the tour with a group photo. Mr. Nonnenberg shouted out a big “thank you” to our Band, Cheerleaders, Mighty Knight, Athletic Image for donating the t-shirts, Crystal Savage for decorating and Mrs. Molino for coordinating the event.
- February’s “Mystery Singer” was Mrs. Maciejczak who sang: “I’d like to Teach the World to Sing” with Mrs. Hettes’ class guessing the singer and winning candy from Mr. James’ candy cart.
- From the Career and Advisor Corner...Mr. Major, planned a trip to Proctor and Gamble with 8 students who are interested in joining the workforce directly after high school. A trip to the Bloomsburg Theatre Ensemble is also planned for April. A junior student at Lake-Lehman has been accepted to the Geisinger Co-Op Program for the first time. A student who has been shadowing one of our Speech Pathologists has taken steps to sign up for a Speech and Language Pathology Camp at Misericordia University. An “Each One, Teach One” new student volunteer initiative was started by Mr. Major and 2 students from Lake-Lehman are actively volunteering to tutor students in the Lehman-Jackson Elementary.
- February students and teacher of the month were celebrated with a pizza party with over 60 in attendance. Mr. Gorski, February Teacher of the Month, along with the 12th grade student of the month was treated to park in a V.I.P. parking spot with a custom name plate on the sign.

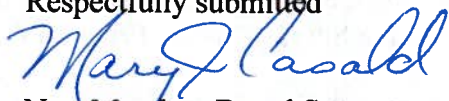
