The Governing Board reserves the right to hold special meetings at places other than the location mentioned above.

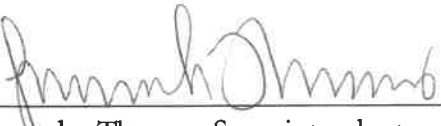
