Executive Director of Special Education Report

Special Education Director, Sara Kral, provided an update on MDE monitoring, reporting that each member district has received notification letters and has until 2027 to hold IEP meetings and ensure required corrections are completed. She also noted that CEIS letters have been issued, including Year 1 and Year 2 warnings related to over-identification. Sara reported that the teacher contract is pending teacher ratification and will proceed to a vote, noting that the board has already approved the contract. Additionally, she shared that Janesville-Waldorf-Pemberton (JWP) is in communication regarding joining MVED's member districts and utilizing MVED's services.

MVED Principal Report

MVED Principal, Tanner Schraw, provided an update on current student enrollment, noting an influx of elementary students. He shared that students continue to work toward transitioning back to their home districts. Tanner also reported that the Crisis and Behavioral Team continues to meet regularly to ensure staff are aligned on students' behavior plans and safety protocols. Additionally, he noted that conferences will be held this week and that Fastbridge and Capti testing is beginning.
