

MINUTES OF THE BUDGET & REGULAR MEETINGS OF THE GOVERNING BOARD
OF THE HEBER-OVERGAARD UNIFIED SCHOOL DISTRICT NO. 6

July 9, 2025

CALL TO ORDER

The meeting was called to order by Board President Tim Leedy at 7:06 pm. Mrs. Hall led the prayer, and the pledge was led by Mr. Leedy.

3. ROLL CALL

Those in attendance were: Tim Leedy, Wendy Hall, Craig Blackburn, Pattie Weber, Christin King, Ron Tenney, Nathan Stoelk, Reed Porter, Andrea Despain and Amanda Crandell.

BUDGET HEARING

The board conducted a budget hearing to review the District's financial plans for the upcoming year. They discussed the preliminary budget figures, including the per-student allocation and the breakdown of funds for maintenance and operations, classroom site, and unrestricted capital outlay. The meeting also discussed the impact of homeschooling and ESA (Educational Savings Account) programs on public school funding. Members expressed concerns about the financial implications of students leaving public schools for homeschooling or charter schools. The discussion highlighted that while homeschooling families can receive up to \$8,000 per child from the state, public schools only receive about \$6,000 per student. It was also explained that the budget would undergo revisions in September and potentially in December and May, depending on the actual student count.

Mr. Nathan Stoelk reported that the ASA Conference he recently attended was really beneficial. The Summer Enrichment classes have finished. Capps has received a \$10,000 STEM grant, congratulations to Mrs. Bove! We're grateful for her efforts in working on this grant. Ms. Woley is looking into starting a Student Government group for the students at Capps. Mr. Stoelk also reported they are working on revising the Student Handbook & Faculty Handbook for this new school year.

Mogollon Jr High & High School

Mr. Reed Porter reported that football camps are here and our facilities are fully booked this year. He also reported positive test scores for ASA & ACT test results along with a high career and college readiness index score from our Senior class.

Business Manager Information

Mrs. Andrea Despain reported that levy funds are sitting well. She also discussed the district's budget, noting some negative grant balances due to a fiscal hold, and mentioned that the Auditor General's website indicated the performance audit review was complete.

Superintendent Report

Mr. Ron Tenney reported that he enjoyed his time spent touring each of the campuses and gave an update on facility inspections & viewed the needs of each campus. He saw how much stuff we have collected over the years. There was discussion about cleaning up storage spaces, including the old Ag Room and a storage box filled with old materials. A plan will be developed to explore options for disposing of or re-purposing the stored items. Mrs. Despain is set to investigate state surplus opportunities next week. The discussion also covered challenges with tracking the white fleet vehicles, particularly for auditing purposes, and a new system was developed to monitor mileage and driver accountability through tracking devices. It will now track who is driving which vehicles, get notices for speeding, etc. We will also be able to track miles by sport/event now. A drivers training is now happening with coaches that are not regular employees.

Mr. Porter talked about the theme "Put Your Name On It" to encourage doing work well enough to be proud of it.

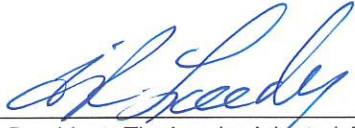
