**MOTION** by Mr. Alesantrino, seconded by Mr. Phillippi, to appoint Dr. Rocco Mantini to fill the unexpired term of Jeffrey Alesantrino as Board Treasurer, which ends June 30, 2026.

**MOTION** by Mr. Phillippi, seconded by Mr. Alesantrino, to appoint Dr. Rocco Mantini and Melanie Byer as the School District's representatives and Earl Sleek, II, as the alternate representative on the Joint Operating Committee for the Greater Johnstown Career and Technology Center for the term from December 2025 through November 2026.

**Recorded vote: All Directors present voted in the affirmative.**

**MOTION** by Dr. Mantini, seconded by Mrs. Maurer, to reappoint Melanie Byer as the PSBA Liaison.

**Recorded vote: All Directors present voted in the affirmative.**
