The Offeror further agrees, upon written notice of acceptance of this Bid at any time within sixty (60) days after the date of opening of the bids, that Offeror will execute the Contract in accordance with the Bid as accepted, and give bond, as sufficient surety, in the amount of one hundred percent (100%) of the Contract Amount, within two (2) working days after a Notice of Award is presented for the following sums:

It is understood and agreed that the work under the Contract Documents shall be commenced by the Offeror, if awarded the Contract for the Project, on the date specified as the Start Date in the Notice to Proceed issued by the Owner in the manner specified in the Contract and General Conditions, and shall be completed by the Contractor by sunset, on the 120 days following the notice to proceed. Substantial completion shall be reached by sunset on the 90 days after notice to proceed. If the Work is not completed by these dates, then the Offeror shall pay the Owner the amount of one hundred and No/100 Dollars (\$100.00) per day as liquidated damages.
